



MEMBERSHIP APPLICATION

The Mandate of the Hamilton/Burlington SPCA

The Hamilton/Burlington Society for the Prevention of Cruelty to Animals is a private not-for-profit animal welfare organization dedicated to the prevention of cruelty to animals, the rescue and adoption of homeless pets, providing support to keep pets in loving homes, and the development of respect, compassion and empathy for every living creature.

About HBSPCA Membership

Purchasing an annual or lifetime membership with the Hamilton/Burlington SPCA entitles you to one (1) vote at our Annual General Meeting and our Annual Report, as well as regular updates on the organization. According to HBSPCA By-laws [Section 7.02 (b), (c)]:

An Annual Member (\$40.00 per year) shall

- a) Be a natural person and 18 years of age or older;
- b) Reside or work in the territory served by the Society at the time application for membership is made (City of Hamilton or Burlington);
- c) Have a single vote at all meetings of the Members of the Society;
- d) Pay annual membership fees prior to March 31st of each calendar year in such amount prescribed by the Board. If payment is not received by March 31st in any given year:
 - i. The membership shall cease effective March 31st;
 - ii. The said member shall not be eligible to vote at the next ensuing annual meeting of the members;
- e) Be entitled to resign membership;
- f) Pay the appropriate annual dues for the calendar year in which the application for membership is made with the application and all such dues shall be retained by the Society regardless of the disposition of the application.

A Lifetime Member (\$300.00) shall

- a) Be a natural person and 18 years of age or older;
- b) Reside or work in the territory served by the Society at the time application for membership is made (City of Hamilton or Burlington);
- c) Have a single vote at all meetings of the Members of the Society;
- d) Pay a one-time fee, as prescribed by the Board, upon submitting the application for membership but shall not be required to pay any further fees. In the event the application is not accepted, the fee paid with the application shall be forthwith refunded;
- e) Be entitled to resign membership failing which he/she shall hold membership for life and;
- f) Cease to be a Member upon death.

According to HBSPCA By-laws [Section 7.04 (b)], the process for becoming a voting member of the HBSPCA is in two steps:

1. A submission to the Society by the applicant of an application for membership;
2. A recommendation of membership by a simple majority resolution of the Board of Directors made at a duly constituted meeting of the Board;
